FOOD VENDOR APPLICATION & AGREEMENT

- 1. Booth space is for ONE WEEKEND, April 25 and 26, 2020, during the hours of operation for the Texas Crawfish & Music Festival.**
- 2. Booth space will consist of:**
 - **10' x 20' space, or such other space as selected**
 - **30 amps of electricity (110 watt outlets only)**
 - **Un-covered space behind booth for work area & storage**
 - **Lights for evening hours**
 - **On-site security for set-up through take-down**
 - **Near-by parking for extra inventory**
 - **Access to water at a nearby water faucet**
- 3. Food Vendor will provide the following:**
 - **Your own setup**
 - **All food items, operational equipment, tables/chairs, etc.**
 - **Menu signs (items must be listed in tokens only)**
 - **Extensions Cords of at least 14/3 grade**
 - **Health Permit from Harris County Health**
 - **Copy of your Insurance Certificate - \$500,000 liability with the Erbe Foundation, Spring Preservation League Inc. and Bayer Investments LLC named as additionally insured.**
- 4. The Spring Preservation League Inc. will direct sales of all beverages. Food Vendor is not allowed to sell water, or canned or bottled drinks**
- 5. Food Vendor may sell only those items outlined in its application as approved, and Food Vendor must sell in a manner that meets county health and fire regulations.**
- 6. Food Vendor understands that once Food Vendor is accepted, Food Vendor's space fee will NOT be refunded.**
- 7. The Festival will use a token system for payment of all food and beverage items. Tokens are valued at \$1.00 and \$5.00 each, and may be re-deemed daily.**
- 8. A fee equal to *10% of the face value of all tokens processed* for each Food Vendor will be charged. The fee is based on tokens processed and will be collected upon final settlement.**
- 9. Food Vendor warrants that Food Vendor is solely responsible for the food that it intends to sell at the Texas Crawfish & Music Festival. It is understood that the organizers of the festival, merely rent space to Food Vendor and assume no responsibility for the safekeeping or protection of same. In consideration of and to induce Erbe Foundation and Spring**

Preservation League Inc. to arrange for space, Food Vendor does hereby release Erbe Foundation and Spring Preservation League Inc., their agents and representatives, from any claim, action, demand, or liability arising out of conduct of any nature of Food Vendor, its officials or agents, including its asserted failure to exercise ordinary care and does hereby indemnify from any claim, action or demand by any person for expense or damage arising from the sale of food or services. It is understood that Erbe Foundation and Spring Preservation League Inc. are renting space at the Texas Crawfish & Music Festival to Food Vendor for the sale of food, and assume no responsibility for the supervision or guarding of Food Vendor's products at or within the rental space.

- 10. Tokens Only. Food Vendor will not accept cash or credit cards for sales. If Food Vendor accepts cash or a credit card, a penalty of \$1,000.00 will be assessed against Food Vendor and withheld from Food Vendor's proceeds; and, Food Vendor will be asked to leave the festival grounds immediately.**
- 11. The sale of non-food items is not allowed.**
- 12. No animals are allowed in any booth space during the festival.**
- 13. Food Vendor agrees to sell only the products set forth in this application as approved by the Festival Director, at the agreed upon prices. It is understood that any changes must be approved by the Festival Director prior to the festival. Food prices may not be changed during the Festival.**
- 14. Any Food Vendor selling items not on their application or approved in advance by the Festival Director will be asked to remove that item immediately.**
- 15. Six (6) Badges and Parking Passes are given to Food Vendor at check-in.**
